# SEA Post-Adoption Statement: PART 4 Introduction

The Council has prepared a Culture, Leisure and Sport Strategy (CLSS) to provide a Framework that underpins the direction of Culture, Leisure and Sport provision across East Dunbartonshire over the lifespan of the strategic action. Participation in the arts and culture, sport and physical activity of those living, working and visiting in East Dunbartonshire and improve facilities, assets, opportunities and efficiencies in the use of these resources.

## **Strategic Environmental Assessment**

The CLSS has been subject to a process of Strategic Environmental Assessment (SEA), as required under the Environmental Assessment (Scotland) Act 2005. This has included:

- Taking into account the views of the Consultation Authorities regarding the scope and level of detail that was appropriate for the Environmental Report.
- Preparing an Environmental Report on the likely significant effects on the environment of the draft Plan which included consideration of:
  - The baseline data relating to the current state of the environment;
  - Links between the strategic action with other relevant policies, plans, programmes, strategies and environmental objectives;
  - Existing environmental problems affecting the strategic action;
  - The strategic action's likely significant effects on the environment (positive and negative);
  - The mitigation measures envisaged;
  - An outline of the reasons for selecting the alternatives chosen;
  - Monitoring measures to ensue that any unforeseen environmental effects will be identified allowing for appropriate remedial action to be taken.
- Consulting on the Environmental Report.
- Taking into account the Environmental Report and the results of consultation in making final decisions regarding the strategic action.
- Committing to monitoring the significant environmental effects of the implementation of the plan to identify any unforeseen adverse significant environmental effects and to taking appropriate remedial action. The key findings are incorporated into the following sections.

#### **Post-Adoption Statement**



Area covered by the CLSS:

The geographical area of East Dunbartonshire Council plus Mugdock Country Park (geographically contained within Stirling Council but managed by EDC), and potential linkages, where appropriate, to surrounding Council areas namely: Glasgow, West Dunbartonshire, Stirling and North Lanarkshire.



Purpose of the CLSS:

To provide a framework that will underpin the direction of Culture, Leisure and Sport provision across East Dunbartonshire over approximately the next five years. The strategy aims to increase the participation in arts and culture, sport and physical activity of those living, working and visiting in East Dunbartonshire, and improve efficiency in the use of resources by:

- Making people fully aware of the health and well-being benefits of participating in regular leisure activity and ensuring that leisure and cultural activities are integral to the everyday lives of individuals and communities.
- Helping to achieve wider policy objectives in the areas of crime reduction, education, social inclusion and economic development.
- Identifying areas requiring improvement in terms of provision of leisure and cultural services, or where there are currently no such services but where opportunities for provision may be possible/ viable.

- Ensuring little or no duplication or over provision of services in order to maximise use of resources.
- Establishing an Action Programme detailing specific projects and identifying the responsible bodies for delivering the projects.

# Strategy Ambition and Objectives:

#### **Ambition:**

Through strong partnership working East Dunbartonshire will be a place with first class culture, leisure and sporting opportunities where people enjoy fulfilled and active lives. East Dunbartonshire will be recognised as a leader in the provision of culture, leisure and sport making a significant contribution towards the Scottish Governments purpose of creating a more successful country.

We will further improve the health and wellbeing of our community by increasing participation in culture, leisure and sport. We will strengthen local partnerships and improve local infrastructure and facilities incorporating high environmental and design standards. We will safeguard and increase opportunities for all residents, workers, visitors and volunteers to take part. We will promote the benefits of participation in culture, leisure and sport and the opportunities available.

## **Objectives:**

- To increase participation in culture, leisure and sport for all residents, workers and visitors of East Dunbartonshire in an inclusive and sustainable manner.

Therefore ensuring that East Dunbartonshire has first class culture, leisure and sport venues and services.

- 2.1. Integration of Environmental Considerations in the Culture, Leisure and Sport Strategy
- 2.1.1. This chapter highlights how environmental considerations have been integrated into the final CLSS. **Table 1** highlights how the environmental problems identified in the Scoping and Environmental Reports have been addressed.

# Section 3: Consideration of Alternatives

## 3.1. Consideration of Alternatives in the Culture, Leisure and Sport Strategy

3.1.1. The Environmental Assessment (Scotland) Act 2005 requires the effects of 'reasonable alternatives' to be identified, described and evaluated. The Act states that the Responsible Authority shall give 'the reasons for choosing the plan, or programme as adopted, in the light of the other reasonable alternatives considered'. This section shall describe the process that East Dunbartonshire applied for developing the CLSS.

## 3.2. Reasonable Alternatives to the CLSS

- 3.2.1. In order to determine the SEA preferred option for the delivery of the CLSS, 2 different strategic alternatives for the delivery of East Dunbartonshire's CLSS were assessed against the SEA objectives. Consequently, the SEA preferred alternative was adopted for the development of the final CLSS.
- 3.2.2. **Table 2** provides an overview of the strategic alternatives considered for the CLSS.

#### **Section 6: Conclusion**

### 6.1. The Influence of SEA on the Culture, Leisure and Sport Strategy

- 6.1.1. The Strategic Environmental Assessment process has been a useful and informative tool in assisting with the development of the Culture, Leisure and Sport Strategy (CLSS) and for highlighting the environmental issues and benefits associated with the CLSS. It has been beneficial in assessing the reasonable alternatives available for the protection, management and development of culture, leisure and sport assets, facilities and activities throughout East Dunbartonshire as well as confirming that the Strategy, overall, will have a positive effect on the environment. The assessment process, highlighted throughout the Environmental Report, illustrates where the SEA has influenced the decision making process and impacted on the Ambition, Objectives and Actions taken forward into the Strategy itself.
- 6.1.2. The views of the Consultation Authorities have been incorporated in to the final version of the Environmental Report and integrated into the adopted East Dunbartonshire Council CLSS. As part of the consultation period and through the Council approval process a number of alterations, including new actions, were proposed. Each alteration was reviewed prior to this Post-Adoption Statement and finalised Environmental Report to determine the likelihood of significant effects. The review indicated that each of the alterations presented minor positive impacts on population and human health and cultural heritage, however the effects were unlikely to be significant or change the cumulative nature of the Strategy as a whole on the local environment. The process effectively screened each alteration out of requiring a full assessment as part of the Environmental Report consultation. A Screening process was undertaken on the alterations to determine their likely significance to help make a decision as to whether an Environmental Report addendum would be needed. This process confirmed that the impacts of the additional actions were unlikely to be significant and would not change the overall impact of the Strategy as a whole. The screening process undertaken can be viewed in Appendix 2. Monitoring of the significant effects will be carried out in line with both the SEA and Strategy monitoring frameworks by the Council and any other relevant bodies in order to implement remedial action if required as a result of unforeseen environmental impacts over the life of the Strategy, or in line with the relevant review stages.

#### 6.1.3. The alterations included:

Ambition - The decision was taken to incorporate the unrevised version of the ambition 1
(Appendix 2 - Table 5). This is contrary to the SEA proposed alternative due to the fact that the
policy-maker wanted to retain the ambition at a high level and in order to incorporate the SEA
proposed change, it was incorporated into Objective 4 to retain the benefits of the proposed
alteration within the policy hierarchy of the wider Strategy.

# **Environmental Assessment (Scotland) Act 2005** Leisure & culture strategy 2015 - Environmental Report

Thank you for your Environmental Report (ER) consultation submitted under the above Act in respect of the Leisure & culture strategy 2015. This was received by SEPA via the Scottish Government SEA Gateway on 28 September 2015.

We have used our scoping consultation response to consider the adequacy of the ER and this is used as the framework for detailed comments which can be found in Appendix 1. For convenience, these comments have been structured to reflect that of the ER. Please note, this response is in regard only to the adequacy and accuracy of the ER and any comments we may have on the Leisure & culture strategy itself will be provided separately.

As the Leisure & culture strategy is finalised, East Dunbartonshire Council as Responsible Authority, will be required to take account of the findings of the Environmental Report and of views expressed upon it during this consultation period. As soon as reasonably practical after the adoption of the plan, the Responsible Authority should publish a statement setting out how this has occurred. We normally expect this to be in the form of an "SEA Statement" similar to that advocated in the Scottish Government SEA Guidance. A copy of the SEA statement should be sent to the Consultation Authorities via the Scottish Government SEA Gateway on publication.

Thank you for consulting Historic Scotland on the East Dunbartonshire Council - Culture, Leisure and Sport Strategy 2016 to 2012.

On 1 October 2015, Historic Scotland and The Royal Commission on the Ancient and Historical Monuments of Scotland (RCAHMS) ceased to operate and have been replaced by a new organisation, Historic Environment Scotland (HES). This new organisation (which is a Non Departmental Public Body) was established by the Historic Environment Scotland Act 2014.

Consultations received by Historic Scotland before 1 October require a response direct from Scottish Ministers. This letter contains Scottish Ministers' comments for our historic environment interests in the context of our role as a Consultation Authority under the Environmental Assessment (Scotland) Act 2005.

Ministers have sought the advice of Historic Environment Scotland on the Environmental Report. This advice is set out in the Annex below. ### General comments

Historic Environment Scotland is content that the assessment and findings in relation to the historic environment are appropriate, and commends the clarity with which the assessment has been set out in the Environment Report (ER), and in which the findings have been reported. This is particularly true of the way in which the ER describes amendments to the Strategy which have been influenced by the SEA process.

#### Monitoring

As the assessment has identified the potential for direct (physical) and indirect (setting) impact on historic environment assets, some of which are be mitigated through application of high environmental and design standards, the Responsible Authority could consider including a monitoring indicator which will capture these effects and the success of the mitigation measures. For example, 'number of planning / listed building consent / conservation area consent / scheduled monument consent applications connected to the Strategy outcomes /actions where adverse effects are predicted'.
