#### Environmental Assessment (Scotland) Act 2005 Leisure & Culture Strategy 2015 - Screening Report

Thank you for your Screening Report consultation which SEPA received via the Scottish Government SEA Gateway on 14 February 2014.

In accordance with Section 9(3) of the Environmental Assessment (Scotland) Act, 2005, we have considered your screening report using the criteria set out in Schedule 2 for determining the likely significance of effects on the environment. It is unclear if the strategy will allocate sites for new leisure facilities or if is more about encouraging greater use of existing facilities. If the strategy influences the location of new leisure facilities which have not been assessed through other plans such as the Local Development Plan some environmental effects are likely.

Having reviewed the Screening Report, we consider that in respect of our main areas of interest (air, water, soil, human health, material assets (of which we have a specific interest in waste) and climatic factors) the strategy could have significant environmental effects.

Although we are of the view that there is a possibility for significant environmental effects, it is for the Responsible Authority to make a formal determination taking into account the consultation responses received. If it is formally determined that SEA is required, you will be aware that the next stage requires the Responsible Authority to consult the Consultation Authorities on the proposed scope and level of detail to be included within the Environmental Report. This can be undertaken through preparation of a concise Scoping Report.

We would encourage you to use the scoping process to focus the assessment on those SEA issues upon which there are likely to be significant environmental effects, to outline the baseline information you consider as most relevant and explain your proposed methodology of assessment.
